Notes for upcoming SD ENA Conference Call/Meeting - 5/14/2013

2013 Summary Report:

2013 TNCC Classes 6th Edition (January – April 30, 2013)

- 13 classes have already been held (12 Provider Courses; 1 Instructor class)
 - 4 Course Directors have reported
 - 171 nurses have taken the Provider Course
(Final attendee numbers pending on 2 courses)
 - 7 new Instructor Candidates were trained
- 8 future classes on the National ENA webpage and also listed on SDENA website
- A TNCC-Instructor class has been scheduled for Friday, October 18, 2013 and is listed on the website

****TNCC is currently under revision (7th Edition)**

- Per ENA State Trauma/Pediatric Chair Committee Conference Call 2/6/2013
 - "TNCC Revision Work Team is actively working and plans to have the pilot ready by aqsummer 2013. There is still discussion on how the pilot will be implemented. New Jersey and Maryland have offered to help.
 - The rollout of the new course will begin after the winter holidays."
 - ?? sometime in early 2014?? - Limited information currently available but will keep the members up-to-date as more information is provided...
 - "There will **not** be a TNCC 7th Edition Reverification Course."

****TNCC & ENPC Administrative Procedures Manual has been updated (January 2013)**

- TNCC Reverification courses can continue to be held; however, **effective 12/31/2012, no contact hours can be awarded for attending the course** (see December 2012 CourseBytes explanation below).
- Non-RN healthcare providers who work in an emergency setting can participate in the written and skill station testing of both the ENPC and TNCC Provider courses. The non-RN healthcare worker who attends a

Provider course will receive a certificate of attendance with the appropriate number of contact hours, but will **not** receive a verification card or verification status.

TNCC REVERIFICATION COURSES (ENA CourseBytes December 2012)

TNCC Course Directors were notified via email in November, that the ENA Board of Directors met on October 24th and decided that the 6th edition TNCC Reverification courses can continue to be held after 12/31/12. As of 1/1/2013, however, no contact hours can be awarded for attending a TNCC Reverification course. This decision was made after receiving quite a bit of feedback from course directors indicating that the availability of the one day Reverification course option, even without the ability to award contact hours, would provide them with a much needed option for many institutions.

Pediatrics Committee

On May 8, 2013, I attended the State Trauma / Pediatric Conference Call via teleconference. Starting Monday, May 13, 2013, Course Directors will be able to access TNCC/ENPC instructor evaluation reports online.

The Trauma/Pediatric Team site will contain conference call notes under the shared documents section. They also discussed the updated GENE - Geriatric Emergency Nursing Education course that will be coming out online late fall of 2013. Much work has gone into upgrading and making this an exceptional course.

ENA opened up discussion regarding the downloadable ENPC supplement vs. the paper copy. Most participants commented that their State ENA had purchased the paper copy for their instructors and most preferred that method in order to make notes. A question was raised whether upgrades to the downloadable version would be automatic. ENA has not made a decision on this yet, but the Instructor manual has already been revised and reprinted. They will keep us informed as to their decision with future updates to the downloadable Instructor manual.

The remainder of the meeting was reserved for networking with regards to the 4th edition ENPC Course. Overwhelming response from the State Pediatric Committee Chairs was that they were experiencing over 50% fail rates with the 4th edition course. Questions were raised regarding ENA's action on the exam and if they were analyzing the results as they came in to look at patterns in frequently missed questions on the final exam. ENA is in the process of re-validating the exam.

- ✚ *Some states expressed great concern over the high fail rate and cost of the course. Some institutions are considering switching to a PALS requirement rather than ENPC.*

- ✚ *Pre-course work:*
 - *Concern was expressed over the pre-course work that is required. Most of this work is being done off-duty since it takes approximately 2.5 hours to complete which includes watching power point presentations and taking post-course work exams. Typically, the work cannot be accessed on auto log-in computers at work, and the time taken away from patient care. There is also concern expressed about staff not being reimbursed for this pre-course work since it is typically done from home.*
 - *If participants are unsuccessful with the exam, they have a limited amount of time to study the pre-course work since it is only open for 10 days, so sometimes this information is not available for them to prepare for the retest. ENA has contracted with an outside vendor to set up the pre-course work, so participants would need a 2nd email in order to give them access to this information.*
 - *Some institutions are downloading this information for participants in a PDF so they are able to keep the information.*
- ✚ *4th edition ENPC Instructor update had a 3.5% fail rate.*
- ✚ *Concern expressed over the Pediatric Clinical Considerations:*
 - *Makes the course way too long.*
 - *Very redundant material.*
- ✚ *Because of the high fail rate, instructors are teaching for the test.*
- ✚ *Because of the cumbersomeness of the Provider Course, some states have moved from 2 consecutive days, to spreading the course over a 2 week period of time. Massachusetts and Florida had moved to this format even with the 3.0 version. They have the course one day on week one and then a week later have the 2nd day. They have had much greater success and feel that participants are much better prepared.*
- ✚ *New York has done some creative scheduling incorporating lectures followed by appropriate hands-on scenarios/vignettes. For example; they do the respiratory lectures and then follow with the respiratory scenario in order to validate the information. They are going to send their plan of the day to ENA and this information is to be posted in the future on the website for Course Directors.*
- ✚ *Larger states such as California expressed concern of mentoring new Course Directors at the state level. Because of their large geographical area and concern with maintaining the integrity of ENPC Course Directors, states such as California have divided into regions in order to specifically assign Faculty to new Course Directors for mentoring.*

Minutes to the State Trauma / Pediatric Conference Call will be posted on the ENA website. No further business was discussed.
